However, as we have previously reported, the Commission has already committed to tabling a legislative proposal by 2021 which would require businesses to conduct due diligence in relation to the human rights and environmental impacts of their operations and supply chains.

First steps taken towards a mandatory human rights due ...

The Commissioner's announcement comes after the publication of the European Commission's study on due diligence requirements through the supply chain, conducted by the BIICL, which underlined the failure of corporate voluntary measures and affirmed the need for mandatory rules at EU level, as Reynders explained.

Commissioner Reynders announces EU corporate due diligence ...

This study for the European Commission focuses on due diligence requirements to identify, prevent, mitigate and account for abuses of human rights, including the rights of the child and fundamental freedoms, serious bodily injury or health risks, environmental damage, including with respect to climate.

Study on due diligence requirements through the supply ...

In April 2020, the European Commissioner for Justice, Didier Reynders, announced that the European Commission was committed to introducing legislation in 2021 to make human rights due diligence mandatory for all EU companies following recognition that voluntary action has not brought about the necessary behavioural change at corporate level.
